Improper Payments

Bribes, kickbacks and similar payments to government officials, ATI Products Inc employees or agents acting on ATI Products Inc's behalf are strictly prohibited. This prohibition also applies in areas where such activity may not violate local law.

Child Labor

ATI Products Inc will not engage in or support the use of child labor. Suppliers are expected to comply with applicable local child labor laws and employ only workers who meet the applicable minimum legal age requirement for their location. In the absence of local law, suppliers shall not employ children under the age of 14.

Forced Labor

ATI Products Inc will not engage in or support the use of forced or involuntary labor. ATI Products Inc will not purchase material or services from a supplier utilizing forced or involuntary labor. Compensation and Working Hours ATI Products Inc pays employees a competitive wage. Suppliers are expected to comply with all applicable wage and hour labor laws and regulations governing employee compensation and working hours.

Discrimination

ATI Products Inc supports diversity and equal opportunity in employment. Unlawful discrimination in the workplace is not tolerated. Suppliers are expected to comply with all applicable local laws concerning discrimination in hiring and employment practices.

Environment

Suppliers are expected to conduct their operations in a way that protects the environment. Suppliers are expected to comply with all applicable environmental laws and regulations in the countries in which they operate.
